WYALUSING BOROUGH
SEWER USE ORDINANCE

AN ORDINANCE AMENDING CHAPTER NO. 52, SEWER USE ORDINANCE, OF THE CODE OF THE BOROUGH OF WYALUSING, COUNTY OF BRADFORD, COMMONWEALTH OF PENNSYLVANIA

The Borough of Wyalusing hereby ordains and enacts as follows:

Under **Section 3.4 Charges**, of the Code of the Borough of Wyalusing, hereby **deletes** the following:

B. The sewer use charges for the use of the Wyalusing Municipal Authority's Sewer System shall be originally set at the following rates:

1. All Residential Users shall be charged \$25.00 per month per E.D.U. (said unit set forth in paragraphs C). The annual sewer user charge will be \$300.00.

2. All Commercial users not using in excess of ten thousand (10,000 gallons of water consumption shall be charged \$25.00 per month per E.D.U. (said unit set forth in paragraph B). The annual sewer user charge will be \$300.00.

3. All Commercial users using an excess of ten thousand (10,000) gallons of water shall pay .0065 cents per gallon.

C. All Residential, Commercial and Industrial User shall be charged based on the number of units on the property or based on the equivalent number of EDU's associated with the property.

D. The Authority shall from time to time in accordance to paragraph 3.3, and upon the recommendation of the Authority Engineer amend the Sewer Service Charge by Resolution.

Under **Section 3.4 Charges**, of the Code of the Borough of Wyalusing, hereby **adds** the following:

B. The sewer use charges for the use of the Wyalusing Municipal Authority's Sewer System shall be originally set at the following rates:

1. All sewer users, residential, multi-unit, commercial, industrial, retail, or non-residential shall be charged 0.007 per gallon with a 4,000 gallon minimum charge per month (\$28 per month minimum per consumer).

a. All sewer users will pay for sewer commensurate with their water use.

b. Usage beyond 4,000 gallons per month charged by the gallon based on the water meter (with the exception of sewer only customers).

C. All Residential, Commercial and Industrial User shall be charged based on the number of units on the property.

D. The Borough of Wyalusing delegates to the Wyalusing Municipal Authority the power to regulate the sewer rates, including increasing or decreasing said rates as deemed appropriate by the Wyalusing Municipal Authority. Furthermore, the Borough delegates to the Authority the power to collect the sewer accounts and to institute legal action to collect delinquent accounts, and the power to file municipal liens as required. Furthermore, the Borough of Wyalusing authorizes the Wyalusing Municipal Authority to increase or decrease said rates by resolution of the Authority at a duly advertised Authority meeting. Said sewer rate increase shall be subject to approval by resolution of the Borough of Wyalusing Council at a duly advertised Council meeting. Said Borough Resolution for sewer rate increase shall be adopted prior to the Authority implementing a sewer rate increase.

THIS ORDINANCE shall take effect as of June 1, 2014.
